PAYMENT SCHEDULE

The non-refundable, non-transferrable booking fee (the “Booking Fee”) made payable to Renault reserves the exclusive date for the Event and access to our expertise and counsel with regard to the Event. The Booking Fee shall be paid in full by client simultaneously with the execution of this Agreement. The Booking Fee is applied toward your estimated gross amount payable by client pursuant to this Agreement.

The second event fee payment (“Final Payment”) will be based upon the number of guests attending the Event, and other services and upgrades selected by client with regard to the Event. The Final Payment shall be an amount equal to the total gross amount payable by client pursuant to this Agreement, less the previously paid Booking Fee and Deposit. The Final Payment shall be paid no less than two (2) weeks prior to the date of the Event. To the extent that additional services, upgrades, changes (including but not limited to additional guests) are added to the Event, or other price adjustments are required pursuant to this Agreement, after client has paid the Final Payment, and additional payment shall be made by client no later than the date of the Event (the “Adjustment Payment”) pursuant to an invoice to be provided by Renault (the “Adjustment Invoice”).

All payments made pursuant to this Agreement shall be made by cash, check or credit card. If an exception is made by Renault, in its sole discretion, and a credit card is used to make any payments due pursuant to this Agreement, client shall pay an additional credit card fee equal to three percent (3%) of such amount paid.

The Booking Fee serves to reserve an exclusive date and access to our industry expertise and counsel with regard to the Event and is therefore NON-REFUNDABLE under any circumstances. Subsequent tendered payments are subject to the following Cancellation Policy.

All cancellations of an Event by client shall be made in writing and delivered to Renault (a “Cancellation Notice”). In the event that the Cancellation Notice is received by Renault more than fourteen (14) days prior to the date of the Event, client shall relinquish the non-refundable Booking Fee, but have no further obligations to make any other payments due pursuant to this Agreement.

In the event that the Cancellation Notice is received by Renault less than fourteen (14) days prior to the date of the Event, client shall relinquish the non-refundable Booking Fee, and shall pay a cancellation fee in an amount equal to the final event balance payable by client pursuant to this Agreement (the “Cancellation Fee”).

INSURANCE

Insurance is required for events with a guest count of one hundred (100) or more. No less than seven (7) days prior to the Event, client agrees to provide a Certificate of Event Insurance evidencing one million dollars (\$1,000,000.00) General Liability Insurance naming Renault as Additional Insured. Coverage must be endorsed to include a Waiver of Rights of Recovery and Subrogation as well as be Primary and Non-Contributory with or more than any coverage Renault may carry.
